Section 1: Summary of Major Events

Contractor and Policy Update

There were no contractor or policy updates during October 2022.

Locality Update

The usTLD Locality space is monitored by Registry Services to ensure adherence to usTLD policies and procedures. We now have 12,490 total usTLD Locality names. Of those, Registry Services manages 9,381 as the Delegated Manager, and the remaining 3,109 are covered by external Delegated Manager Agreements.

There were 0 Delegated Manager agreements executed this month, had there been any, they would be existing Delegated Managers.

Technical and Operational Update

There were no operational changes during October 2022.

Marketing Update

October marketing consisted of evergreen paid ads, organic social media activation, content creation, partner events and sponsorship of the annual NASA Space Apps international hackathon challenge.

The NASA International Space Apps Challenge (Space Apps) is an international hackathon for coders, scientists, designers, storytellers, makers, builders, technologists, and others in cities around the world, where teams engage the National Aeronautics and Space Administration's (NASA's) free and open data to address real-world problems on Earth and in space. The annual Space Apps challenge was held October 1-2, 2022. Participants from around the world gathered at in-person and virtual local events over the two-day hackathon to solve challenges submitted by NASA experts. After the hackathon, project submissions are judged by space agency experts and winners are selected for one of 10 Global Awards. All participants were offered a free .US domain scholarship to launch their idea, personal project another online initiative as part of the Registry Services annual sponsorship for the event. This year's attendance saw the largest turnout in Space Apps history, with over 31,500 registered participants, in 62 countries and territories, forming 5,327 teams! The Global Finalists will be reviewed by an executive committee from NASA and partner space agencies and announced in the coming weeks.

In addition to the Space Apps sponsorship, key partnership efforts continued with Startup Weekend and Major League Hacking events throughout the month. Startup Weekend hosted 44 events in 13 different countries with just over 3,600 global participants. The Major League Hacking events total eight throughout the month with the Global Hack Week taking place October 23 - 30th. Winners included projects with domains such as scoobadivewith.us.

Paid marketing ran continuously throughout the month on Facebook, Instagram, Youtube and Paid Search. Always-on messaging keeps .US domains top of mind for entrepreneurs and small businesses coming online. Results below:

- Impressions - 835K
- Website Visits - 8,590
- Website Conversions - 694

Organic traffic continues to remain strong with a 5% lift in sessions from the previous month. In addition to high-quality curated content, efforts to engage the community on social media included 87 posts and tweets across Facebook and Twitter channels.

Other Updates

New registrations in October 2022 were 21.85% lower than October 2021. Names under management in October 2022 were 10.68% higher than October 2021. The renewal rate in August 2022 (most current data available due to 45-day grace period) was lower year over year at 84.52% vs. 86.69% in August 2021.
