Monthly Progress Report for June 2022

Section 1: Summary of Major Events

Contractor and Policy Update

Registry Services LLC, attended in-person to ICANN 74, held June 13-16 at The Hague, Netherlands. The last time ICANN held an in-person Policy Forum was in Marrakech from 24-27 June 2019. In June 2019, there were 1,186 in-person attendees, which isn't significantly higher than the 878 in-person attendees at The Hague. The big change is in the number of sessions with 173 being conducted in Marrakech and only 105 in The Hague.

A quick review of the Summary Report from the Marrakech meeting identified DNS Abuse as the new hot topic gaining community attention while the intensity surrounding GDPR seemed to be waning. DNS Abuse continues to be the topic that has considerable attention. There seems to be a push from some parts of the community, including the GAC and a GNSO Council DNS Abuse Small Team, to solve the problem of DNS Abuse through contract amendment changes for ICANN contracted parties rather than a policy development process.

During ICANN74, the ccNSO held various sessions including Tech Day, ccNSO Members Meetings, and ccNSO Council sessions. The ccNSO Council held a session to adopt its work plan for fiscal years 2022–2024, which details the expected duration of ccNSO policy development processes (ccPDPs) and ccNSO administrative tasks. In addition, the ccNSO Council appointed new leadership teams for the ccNSO Internet Governance Liaison Committee and ccNSO Meetings Program Committee. The ccNSO Council also adopted the timelines for the ICANN Board Seat 11 nomination process and the upcoming ccNSO Council elections. (*Source: ccNSO Policy Outcome Report, July 2022*)

The usTLD Stakeholder Council met for the Q2 meeting on June 9, 2022, at 12:00 pm Eastern Time. The agenda included a marketing update about the 20-year celebration of .US in the second level with a comprehensive integrated marketing campaign. Global activation included registrar partner promotions, flash sales, paid media awareness activities and dedicated content. There were also updates from a Security & Policy standpoint including Registry Services sharing its continuation of discussions with the NTIA regarding Accountable WHOIS and its approval process.

Locality Update

The usTLD Locality space is monitored by Registry Services to ensure adherence to usTLD policies and procedures. We now have 12,480 total usTLD Locality names. Of those, Registry Services manages 9,371 as the Delegated Manager, and the remaining 3,109 are covered by external Delegated Manager Agreements.

There were 0 Delegated Manager agreements executed this month, had there been any, they would be existing Delegated Managers.

Technical and Operational Update

There were no operational changes during June 2022.

Marketing Update

June marketing continued with our steady drumbeat of content and targeted paid advertising outreach. Social media, including Facebook and Instagram are the main channels leveraged for reaching the small business audience. Creative optimization includes rotating in new ads to keep the messaging and visuals fresh and drive interest for retargeting website visitors. Facebook serves as the platform to engage our target audience and drive consideration for [.]us registrations. To complement our engagement efforts, paid search is an integral component of our overarching strategy. Paid Search re-engages with users at the point of purchase, when people are ready to register their domains. This conversion level marketing tactic supports overall registration growth for [.]us domains, and is our top performing marketing channel for website leads. Additionally, awareness level efforts include a paid YouTube preroll video campaign based on domain keyword searches and SMB and entrepreneurial interests. Video content is a growing market opportunity as more time is spent watching online videos across the web every day. YouTube is the second largest search engine after Google and ensuring [.]us has placement on this platform allows increased reach to support brand affinity and recall.

Helpful business tips and small business resource content continue to be the top-performing articles for driving organic traffic to the about[.]us website. This keyword-rich content indexes well in Google and provides viewers with a positive and quality brand experience of [.]us. Total year-over-year traffic is up 40% to the about[.]us website with blog traffic averaging one minute and 26 seconds on site (vs. 49 seconds for the sitewide average). Efforts for content will continue throughout the year to drive long-term search engine optimization for [.]us brand awareness in the SMB market.

Other Updates

New registrations in June 2022 were 25.58% higher than June 2021. Names under management in June 2022 were 9.87% higher than June 2021. The renewal rate in April 2022 (most current data available due to 45-day grace period) was lower year over year at 76.69% vs. 81.02% in April 2021.
